### **Instruction to Tenderers**

Director Atal Bihari Vajpayee Institute of Mountaineering & Allied Sports Manali invites tender by mode website & advertisement in newspaper on item rate basis from eligible Contractors/ Vendors / Distributors / Authorized Vendors for specific compasses for import of non scheduled item and having expertise of schedule items through directly themselves/ hired civil engineers .

1. The bidding document can be downloaded from the website [www.adventurehimalaya.org](http://www.adventurehimalaya.org) from **27/05/2019 to 24/06/2019 up to 1800 hours.**
2. The bid shall be deposited by registered / speed post or in person till **24/06/2019 1800 hours.**
3. Technical bids of bidders shall be opened in the office of the Director Atal Bihari Vajpayee Institute of Mountaineering & Allied Sports, Manali (H.P.) on **25/06/2019 at 1200 hours** and technical bid qualifiers financial bid will then be opened only

5. The site of work is available. The intending bidders are strongly advised to inspect the site of work before bidding. Bids must be accompanied by bid security and cost of Tender Document payable at Manali pledged in favour of Director ABVIMAS Manali . Bid security will have to be in form of CDR / FDR and shall have to be valid for 01 year or more after last date of receipt of Bid. The cost of downloaded tender documents shall be in form of Bank Receipt in favour of Director ABVIMAS, Manali (H.P.) indicating name of work by depositing the requisite amount charges, in Director ABVIMAS, Manali bank Account No 50055073959 at The Kangra Central Co-Operative Bank Ltd. Manali IFSC Code: KACE0000035 The bidder shall enclose the copy of bank receipt for cost of tender documents along with technical bid.

No separate intimation about opening of financial bids will be sent by this office/by the tender Opening Authority.
